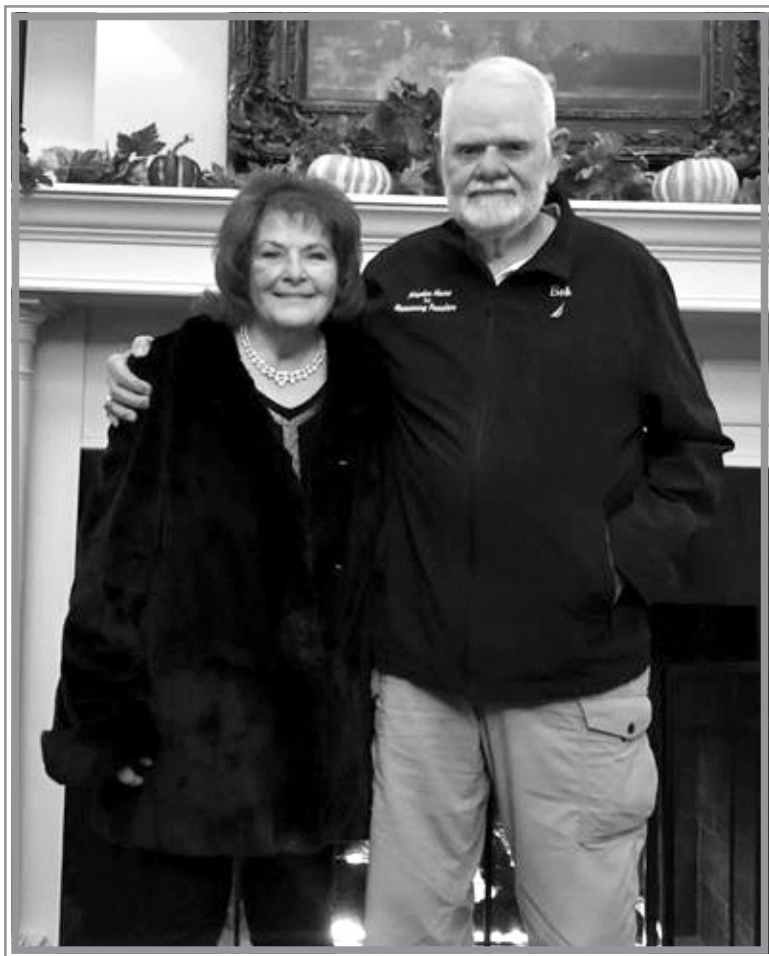

**BOB AND BARBARA HAYDEN**



***God, family, country and dogs.*** That's the answer you'd get if you asked Bob Hayden, what are the most important things in this world. Barbara Hayden would agree, but would add cats, horses, and helping people to that list. Their dedication and passion to one another, their family, their business, the community and the sport of field trials is second to none.

Robert Hayden (85) and his bride of almost 63 years, Barbara (82), met when they were just 4 and 6 years old. Barbara's family moved next door and that's where their story begins. They began dating as teenagers and got married the day after Bob graduated from college. Bob and Barbara have 3 children, 7 grandchildren and 1 great granddaughter.

In 1976, in Covina, California, Bob and Barbara started Starline Brass and began manufacturing the best brass cartridge cases on the market. They moved their business to Sedalia, Missouri in 1990. Still a family owned and operated business to this day, Starline Brass continues to grow and thrive in these challenging times.

Sedalia, Missouri marks the beginning of their love for field trials. Bob and Barbara have always been passionate about animals. Dogs have always been at the top of the list. Bob spent many hours in the field hunting with his dogs. Two of his favorites were "Sissy" and "Buck," his two Brittany Spaniels. In 1993, Bob decided he wanted a duck dog and settled on a Golden Retriever. He named her in honor of Barbara, BJ's Golden Lacey. She was heading off to train with Bill Eckett, at Blackwater Retrievers, to be a duck dog. A couple of weeks into it, Bill Eckett called Bob and asked if he had ever thought about training "Lacey" for Field Trials. At that time, Bob didn't know anything about the game, but wanted to learn. Barbara told Bob she was going to be the one to handle Lacey, and off she and Lacey went to train with Bill. After their second training session, Lacey wasn't doing what she was supposed to be doing, and neither was Barbara. Too many treats and kisses, not enough training. Barbara went home that night and told Bob she was done talking to her dog like that and she would just watch her in the trials and let the pros handle her.

A year later, Lacey was running Derby's and onto Qualifying. Every time Barbara went to go watch Lacey, she would act up and not perform. Lacey could smell Barbara's perfume and she'd lose her head and be hard to handle. Bill Eckett told Barb she would have to go sit in the car and watch from the parking lot. Even that didn't work. The wind changed, Lacey caught a whiff of that perfume, and she was out in the first series. Bill told Barb, she had a choice to make ... quit coming to watch or pull her out of the game (He knew she would never stop wearing her perfume.) That's the last field trial Barbara ever watched. That's when Bob started going to watch Lacey run, and he became hooked.

Lacey ran trials for a couple of years and then had a litter of pups. After a 3-year hiatus, Lacey wanted to go back to work. Bob and Bill weren't sure Lacey could pick up where she left off, but she surprised them all. In 1997, Lacey won a 1st, 3rd, and 4th in the Open and was ranked the Top Golden in the US with 6 ½ points. She missed qualifying for the national by only ½ point. But Bob caught the Field Trial fever. He wanted to learn, train, handle and compete with his dogs. Despite not being very good to start off with, his love for dogs, the game and the sport grew and turned into one of his greatest passions.

After several years of running trials with Golden Retrievers, Bob decided to make the switch to running with Labs. His first Lab was Bocefus. "Bo" went to 6 Nationals and earned over 100 All-Age points. He is still the best dog Bob has ever run.

In 1999, Bob realized that there wasn't any place within 300 miles of Sedalia to compete and a lot of events he travelled to, had grounds that were in bad shape and not safe for the dogs to run. He didn't want to see any dogs get hurt. That's when Bob made the decision to do whatever he could to grow and build the sport and use his property to do both. Bob and Barbara own Wood Dale Farm, a 500+ acre Field Trial paradise in Sedalia, Missouri. Over the last 24 years, they've invested over \$1.1 Million to develop their property and grounds specifically for Field Trials. There are 19 ponds and lakes, 21 mounds including Swede's Mountain, and a kennel operation that Bob built for his personal dog trainer and best friend, Bobby George. Bobby George trained all of Bob's dogs on his property until the day of Bobby's passing.

At 85 years old, Bob is still playing the game. He currently has four 5-year-old Labs running trials and being trained by Seth Steenbergen and one 2-year-old, just getting started. It's very important to Bob and Barbara to make sure there is always a safe and beautiful place to have Field Trials. 100 years from now they'll be running trials at Wood Dale Farm. Bob and Barbara have developed long term lease agreements with several different clubs, including the National Derby, Kansas City Retriever Club, the Missouri River Field Trial Club, Missouri Valley Hunt Club, and The Master Amateur Retriever Club to ensure there's always a home for the sport. These clubs can train on the property year-round for free. He allows clubs to host field trial events at Wood Dale Farm and doesn't charge a dime.

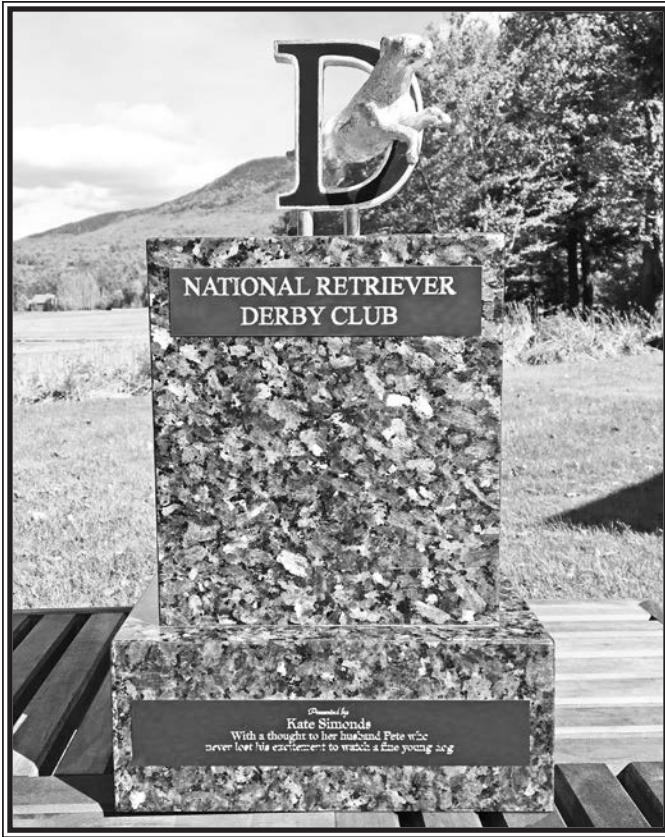
In addition, Bob and Barbara typically sponsor the Field Trial event, providing food, awards, dinners, shirts, oil paintings, you name it!

Helping make Swede Anderson's dream come to life is one of Bob's fondest and biggest accomplishments in the sport. Bob met Swede, the dancing machine, at Bill Eckett's place. They regularly trained their dogs together and talked about how to build and grow the sport. They knew they had to get the younger generations involved and Swede had the idea of starting a National Derby. Swede passed before he got to see the 1st National Derby, but his memory lives on, and he is honored every year. The final series is run, and the winner is crowned on Swede's mountain. Bob and Barbara have hosted the National Derby at Wood Dale Farm for the last six years and look forward to many more! Bob's dream is to host The National Open or National Amateur at Wood Dale Farm when it comes back to the central part of the US. His family and friends dream of seeing him inducted into the Field Trial Hall of Fame, honoring his 25 years of passion and dedication to the sport he loves so much.

Bob Hayden leaves us with a few wise words to remember ... *"It's no coincidence that Dog is God spelled backwards, if everybody acted more like a dog, this world would be a much better place."*

Kate has presented to the National Retriever Derby Club a truly unique trophy to be awarded to the winner for their possession and proper stewardship until the following year's competition. At that time, the next National Derby Champion will accept custody for the subsequent year. And so, a new tradition is underway.

Now on to the trophy itself. This trophy is comprised of the traditional look of a solid sterling silver, sculpted, retriever jumping through the "D." The two-tiered base is a granite finish, which is a new look. Together the presentation is a blending of new and tradition, much like the event itself.

The retriever was sculpted by Carol Bunyon of Stowe, VT and Brays Island, SC. The entire trophy was designed and constructed by Ferro Jewelers of New York and Stowe, VT.

## **Field Trial Etiquette**

1. Please stay in the area designated by the officials.
2. While dogs are being tested, either on land or in the water, please silence cell phone use, refrain from loud talking or other noises, also from unnecessary motions; all may be distracting and may seriously interfere with the dog work.
3. Do not applaud until the dog has completed the test, and is leaving the line.
4. Please cooperate with those responsible for the proper conduct of this championship stake, especially with respect to the handling of traffic.
5. Please show your appreciation for the hospitality extended to us. Help keep the grounds clean and **NO SMOKING** outside your vehicle.
6. The National Retriever Derby Club promotes and expects ethical behavior by all participants at our annual event. When training, attending the trial itself, or attending the many activities around the trial, always think first of sportsmanship, etiquette and the good of the sport. The showcasing of the finest our sport has to offer is the true reason we have assembled. That standard should never be violated or compromised.

## **YOUR COOPERATION IS APPRECIATED**

This is the Seventh Annual National Derby Championship Trial. It is conducted by the National Retriever Derby Club, Inc., under license from the American Kennel Club, Inc.

Qualification for the 2023 NRDC Championship will be three or more Derby points, as recorded by Entry Express and verified by Retriever News. (5 points for 1st place, 3 points for 2nd place, 2 points for 3rd place and 1 point for 4th place.) The qualification period is recorded as all Derby points earned while under age two, which qualify for the Retriever News National Derby List. Any dog under age two on the start date of the first series of the event with the requisite verified three points for 2023 may enter the event.

The Championship event will be managed such that we are completing the trial within five days in ten series equally divided between those on land and those on water.

At this trial the judges will place only the winning dog, which is thereby entitled to the official designation:

*“National Derby Champion of 2023.”*

## National Derby Championship Rotation Order

The starting dog's number will be drawn at the General Meeting the day previous to the beginning of the trial. Each rotation segment is determined by dividing the number of contestant dogs listed in the catalog by a figure of four (4). The rotation numbers will be announced prior to adjourning the General Meeting. Beginning with the starting dog selected during the meeting, this division determines the dogs that start each successive rotation, where a rotation may include more than one series. If any of the numbers are not listed in the callbacks, the next higher number will start. Unequal divisions shall be rounded up to nearest whole number.

By example, dog 20 starts a 75-dog trial. The rotational division would be;

75 divided by 4 = 19 dogs in the rotation where the rotation would be

*Example: 75*

*Dogs Entered / 4 = 19:*

1st - 20

2nd - 39 (= 20+19)

3rd - 58 (= 39+19)

4th - 2 (= 58+19)

Following the fourth rotation, the rotation returns to the starting dog of the trial (20), excluding that dog, and beginning with dog 21, or the first working dog after 21, five (5) working dogs (dogs listed on the callbacks) are counted and the sixth dog would start the fifth rotation.

Rotation for the remaining series of the trial will be, beginning with the dog that started the previous series and excluding that dog, counting five working dogs and the sixth dog would start.

No dog will start any completed series more than once. If the rotation landed on a dog that had previously started a completed series, that dog would be skipped unless all remaining dogs had already started a series and then the dog that was the first to start a series of the remaining dogs in the trial would be starting dog.

The Field Trial Marshal will administer and interpret this procedure in conjunction with the Field Trial Committee.

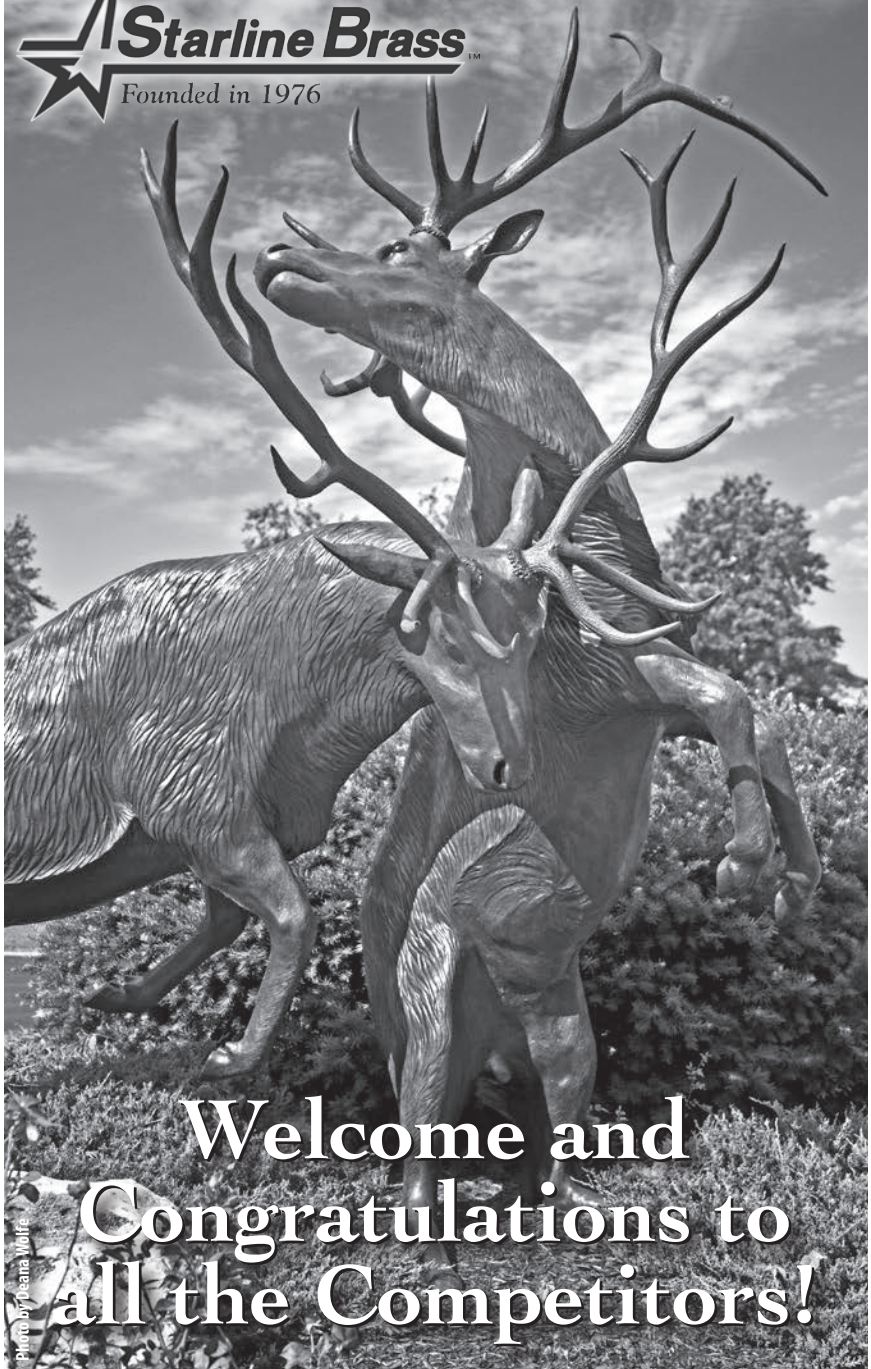
