AN AMBASSADOR FOR THE SPORT

JOHN THOMAS firmly believed that we all need to give back to the retriever game more than we receive; those of us who knew him would say he succeeded.

John went to his first retriever trial in 1975 and was hooked. In a few years he was competing in field trials himself and started developing his property in Rocky Point, NC as a retriever 'playground' (his words). John was active with the Tar Heel Retriever Club and later founded the Cape Fear Retriever Club. Both clubs held trials on the Rocky Point grounds, as did Down East Retriever Club.

John loved to see groups out training and trainers from all over the country took advantage of the grounds for pre-national training and winter training. Amateur groups were encouraged too – locals and out-of-staters – especially out-of-staters who were always treated to a tour of the property at high speed in the 'farm' truck, or in one of several very old Chevy Suburbans that may or may not have once been used as school buses. The tractor was on stand-by, just in case.

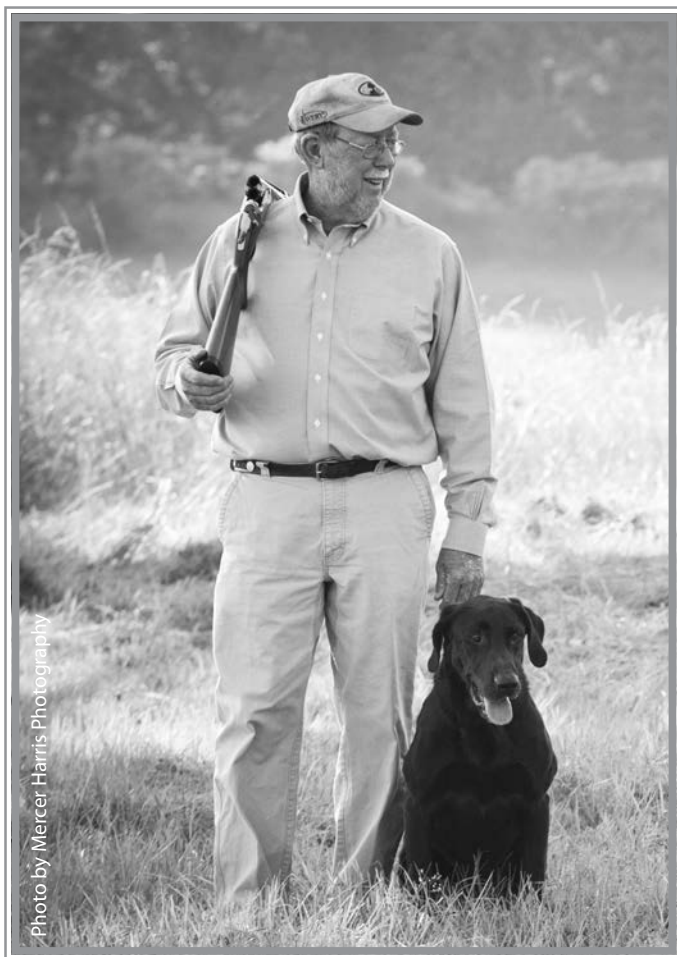
He also liked to show the place off from the air. Before he retired, John used to fly his airplane to field trials. Passengers were welcome.

After having worked at the family business, Thomas Built Buses, first as an engineer, then sales manager, President, and CEO, John had a network of connections all over the United States and Canada. He never forgot a name or a face. If you named a town anywhere in the country, he knew someone who lived there. And if any member of the field trial community was in a bind, he knew somebody who could help and would give them a call.

John judged all over the country including the National Open in 1995. He chaired innumerable trials, served on National committees and successfully presented the case for the Dow Jones Method of determining the draw.

John was very proud to have owned and handled 10 titled dogs including FC-AFC Ragin' Eye Of The Storm, "Cane." Cane was a Double Header winner, a Finalist at the NARC in 2012 and High Point Open Dog in 2013. John was inducted into the Retriever Hall of Fame in 2014 and his beloved Cane followed him shortly after John's death in 2017.

HUGH ARTHUR, SANDHILL RETRIEVERS



HUGH contributed to the sport of trained retrievers for more than 40 years. In that time he co-founded and led retriever clubs (Palmetto and Central Savannah), chaired the bird thrower committee at Nationals, and trained handlers as well as their dogs. Sadly we lost him in 2021.

Hugh opened Sandhill Retrievers in 1974 and established it as one of the premier kennels in the country. In his field trial career, his accomplishments were truly outstanding.

He put more than 100 dogs on the Derby List including the 1990 High Point Derby Dog, Carolina's Full Force Gale and many other Top 5 Derby and Derby List dogs including Hall of Fame member and 2x National Finalist FC-AFC Itchin' To Go, FC-AFC Carolina's Smoke On The Water, FC-AFC Dixie City Jam II, FC-AFC Beggin' To Go, and Josie's Hot Shot Pepper.

The list of Field Champions Hugh trained and handled totals more than 70 dogs. In addition to the Top 5 Derby List dogs who became champions, Hugh also trained FC-AFC Smokey Of Lambert, FC-AFC Moon's Carolina Cajun, FC-AFC Southpaw's Mr. Blue Stomper, FC Dizzy To Go, and FC-AFC Doctor Feel Good VI.

Hugh ran his first National in 1977 with FC Super Joy Of Spring Oaks and won in 1985 with NFC-AFC Dynamite Duke IV. (He was one of very few pros who have run dogs in each of the past four decades.) He also titled the first chocolate female, FC Beggar's Bush Venna and trained the first – and so far only – titled Flat Coat, AFC Jon-Lee's Spring Valley Atari.

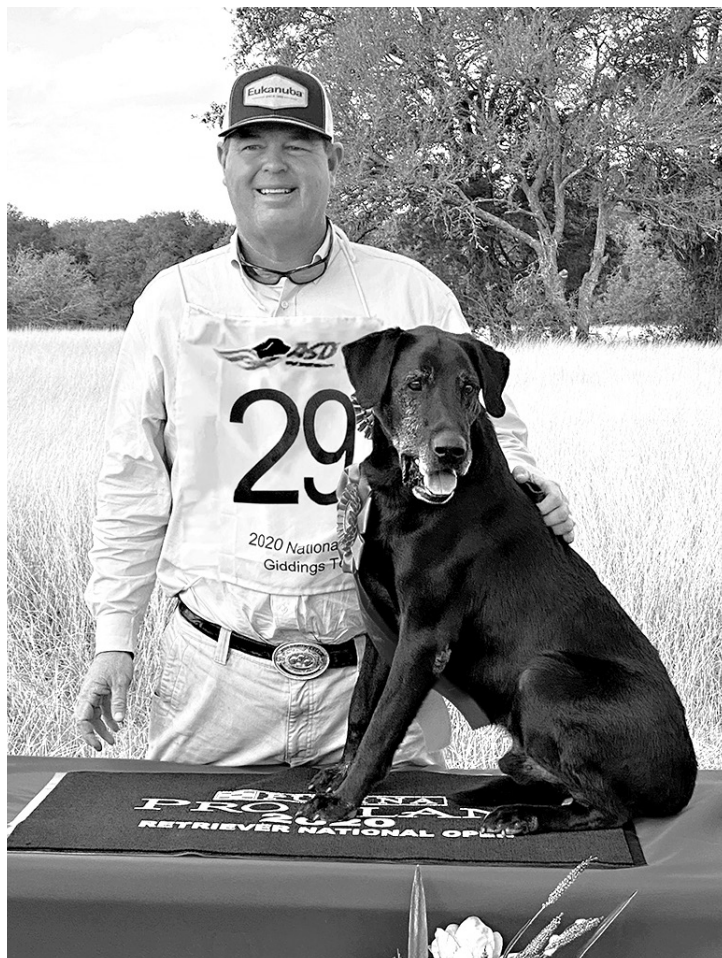
For Hugh, mentoring went beyond training dogs.

Perhaps his greatest legacy is the number of his clients who have judged and chaired Nationals. The list includes Phil Clifton (2x), Mitch Brown, Marshall Dunaway, Bill Goldstein (2x), Frank Kearney, Grayson Kelley (2x), Clint Joyner, Tom Strickland and Randy Whittaker (2x). More recently he took several pros under his wing and helped them build successful field trial careers.

Those fortunate enough to have spent time with Hugh understood that his interests ranged from retrievers to coon dogs and pointers, horse racing and fishing, but most importantly to family. A true gentleman, his values reflected his love of family, respect for competitors and peers, and a genuine enthusiasm for the goals and joy of his clients.

Hugh's accomplishments and commitment to all aspects of the sport – owners, handlers, dogs, events – are outstanding!

Field Trial Etiquette

1. Please stay in the area designated by the officials.
2. While dogs are being tested, either on land or at the water, please refrain from loud talking or other noises, also from unnecessary motions; all may be distracting and may seriously interfere with the dog work.
3. Do not applaud until the dog has completed the test, and is leaving the line.
4. Non-competing dogs are not allowed on the field trial grounds.
5. Please cooperate with those responsible for the proper conduct of this championship stake, especially with respect to the handling of traffic.
6. Please show your appreciation for the hospitality extended to us. Help keep the grounds clean – Extinguish cigarettes and matches.

YOUR COOPERATION IS APPRECIATED

This is the Eightieth Annual National Retriever Championship Trial. It is conducted by the National Retriever Club, Inc., under license from the American Kennel Club, Inc.

The retrievers competing in this trial have qualified in one or more of five ways and are limited to the following:

1. The winner of the 2020 National Championship Stake;
2. The winner of the 2021 National Amateur Championship Stake (must be handled by an Amateur in this Stake);
3. The winner of the 2021 Canadian National Championship Stake;
4. The winner of the 2021 Canadian National Amateur Championship Stake (must be handled by an Amateur in this Stake);
5. Winners of a first place, carrying five championship points, plus two additional championship points in Open, Limited, or Special All-Age Stakes in trials held within the year preceding the National Championship Stake, which are staged by members of the National Retriever Club, Inc., which are also members of, or Licensed by, the American Kennel Club.

National Championship Stakes must include at least ten tests or “series,” equally divided between those on land and those on water.

At this trial, the judges will place only the winning dog, which is thereby entitled to the official designation, “*National Retriever Champion of 2021.*”

National Retriever Championship Rotation Procedure

The starting dog is drawn at the General Meeting the day previous to the beginning of the trial.

The rotation is determined by dividing the number of listed dogs in the catalog by a figure of four (4). These numbers are also announced during the General Meeting. Beginning with the starting dog, this division determines the dogs that start series one through four i.e. dog 35 starts an 80 dog trial. The division would be 35, 55, 75, 15. If any of these numbers are not listed in the callbacks the next higher number would start.

Following the fourth rotation, the rotation returns to the starting dog of the trial (35), excluding that dog and beginning with dog thirty-six (36), or the first working dog after dog thirty-six, five (5) working dogs (dogs listed on the callbacks) are counted and the sixth dog would start the fifth series.

Rotation for the remaining series of the trial would be, beginning with the dog that started the previous series and excluding that dog, counting five working dogs and the sixth dog would start.

No dog will start any series more than once. If the rotation landed on a dog that had previously started a series, that dog would be skipped unless all remaining dogs had already started a series, in which case the dog that was the first to start a series of the remaining dogs in the trial would be starting dog.

Prizes to the Winner only

- Standard AKC Rosette: *National Retriever Field Champion of 2021*
- Gold Club Pin – National Retriever Club, Incorporated
- The Championship Trophy – An Award of the National Retriever Club to the owner of the winner
- The Challenge Trophy – An Award of the National Retriever Club, to remain in the possession of the owner of the winner until the running of the National Championship Stake the following year
- The Challenge Trophy – An Award of the National Retriever Club to the handler of the winner, if a professional, to remain in the possession of the handler of the winner until the next winner of a National Championship Stake is handled by a professional. The handler also receives a replica of this trophy.



In 1991, the PRTA adopted the following set of ethical guidelines for training during the National Championship. Our members pledge to abide by them and we ask all contestants to voluntarily join us in this effort to promote good sportsmanship and fair competition.

Guidelines For Ethical Training at Nationals

The object of the National is to bring out the best performance.

TO FURTHER THIS END:

1. As much training may be done each day as required **BEFORE** entering the trials grounds or **AFTER** running a test. **NO TRAINING** may be done after observing a test until after you have run.
2. Train with as many people as required, excluding any person who has been to the trial and observed the test in progress.
3. Train on designated areas or ask permission on private property.
4. Keep corrections away from the public eye and ear.
5. Dispose of birds in a manner that will not affect public perception, or disrupt another training group.

It is our belief that once a test is viewed, any training which follows will be tainted and distorted by the viewing. Whether training alone or with a group, the viewing of the test will be reflected in what is done and how it is done. This influence is inevitable. Even if only the mannerisms of the handlers are influenced the test will be reflected. It will be reflected in the number of retrieves and whether the retrieves are short or long. It will be reflected in whether the retrieves are across the ditch, along the ditch, up the hill or down the hill, into the wind, crosswind, or downwind. Whether they be marks or blinds, whether "pattern work" sets up a mark or a blind, short or long, the test will be reflected. It may be reflected in so little as voice tone.

Any training done before actual viewing of the test is guesswork. Any training done after viewing is unfair advantage. This advantage is true even if the test is carried into the next day. When a test is carried to the next day the competitors have had the advantage of observing (or training prior to arriving at the trial) all the previous day's work. Often there is also the advantage of partial callbacks. Any "disadvantage" of running the following day is outweighed by the advantage of knowing what the other dogs have done. Training overnight is an unfair advantage to late competitors.

Rotation is the means of neutralizing the draw. By and large it does a good job. Dogs which run early in one test will run late in the next test. Sometimes running early is best, sometimes late is best. One thing for sure, once you've seen the test, any training done is not fair competition.

The future of our great sport depends upon the ethical guidelines which we place upon ourselves. In the final analysis we are only competing against ourselves. We're only winning or losing according to how we conduct ourselves.

When training at any time, caution should be taken to keep the image of field trials at a high level. Ask permission to train on private grounds. Keep corrections away from the public eye and ear and dispose of birds properly.

The object of the National is to bring out the best performance. The best performance involves every aspect of preparation and every part of ourselves. *The winner is within.*

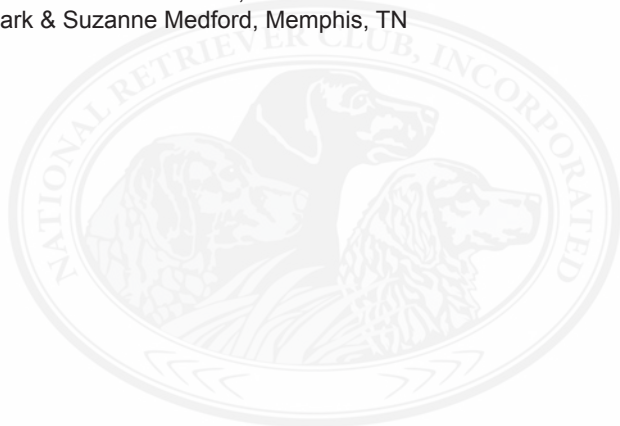

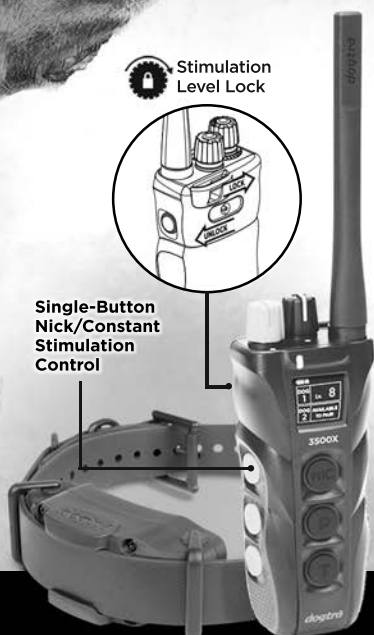
