
Thanks to our team of Judges who I know will test your abilities to the utmost, and will in the end come up with that one special dog to be crowned the 2023 National Field Champion.

The 2023 National Retriever Championship Stake Dedicated to PETER GOODALE



Duck hunting is where it all began. Besides needing a shotgun, Peter immediately realized hunters also needed a retrieving dog. In 1976, Pepper, a black Labrador retriever, joined the family. Peter trained Pepper using Walter's Water Dog book and discovered a new joy in his life: training retrievers. Next came competing in picnic trials sponsored by WVRC. It was not long before Peter realized he needed training for himself. He wanted to be a good dog handler. Every Thursday, Peter drove the distance to Scappose, OR to train with Jerry Patopea, learning dog handling and training skills. This was his routine for at least a year.

It could also be said this is when the life as a field trialer for Peter Goodale was established. He and Pepper excitedly received a green ribbon in their first derby field trial. We thought this sport was going to be easy, but how quickly reality burst our bubble. That is when Jumpin' Black Flash, our next dog, and David, our first child, were welcomed into our family. Flash was Peter's first FC-AFC dog and Peter's first experience to run in a national field trial. After our daughter Julie was born, the children and I traveled with Peter for another four years to trials. It was a tremendous amount of work preparing to leave on Thursday's for trials, come home late Sundays to unpack, and doing it all over again for the following Thursday. Eventually, we could no longer take our son out of school when he reached the first grade. Peter was on his own. I remember Peter staying as late as he possibly could on a Thursday evening to watch David, a first grader, play in a baseball game. Peter was expected to be in Klamath Falls for a trial. I was the baseball coach's assistant. Peter asked me before he left for K Falls, if he too should be helping to coach our children's teams? Field trialing easily takes away from family time. I felt sorry for Peter and the decision he had to make. With a few adjustments. Peter remarkably managed to continue training dogs, field trialing, coach his children in sports, serve the Lord and be a wonderful provider, husband and father for his family all of these years. He continues to give unselfishly and wholeheartedly himself to the best of his ability.


Besides WVRC, Peter supported Klamath Falls and Medford clubs. That did not stop other clubs from asking him to help shoot, throw, marshal or whatever they needed at their trials. If help was needed, Peter could be counted on to contribute to his sport.

Peter has held many positions multiple times for club and nationals: president, field trial chairperson, gun captain, bird thrower chairman, marshal, and so on. He was chairperson for the National Amateur Trial in 1994 on Sauvie Island, OR. Considering this was prior to the internet, Peter and Regina Poer, a lifesaver, spoke to each other endlessly every evening on the phone for an entire year planning the national.

Between judging approximately 66 trials and attending nationals, Peter has traveled all over the US including the east coast, northeast, south, midwest, Alaska, west coast and the PNW. This includes judging the 2009 National Amateur Trial in Virginia, Minnesota.

I mentioned the joy training retrievers brings to Peter's life. It is also worthy to mention his tremendous fondness for the people he has trained with throughout these 47 years and the blessing of lifelong friendships.

Field Trial Etiquette

- 1. Please stay in the area designated by the officials.
- 2. While dogs are being tested, either on land or at the water, please refrain from loud talking or other noises, also from unnecessary motions; all may be distracting and may seriously interfere with the dog work.
- 3. Do not applaud until the dog has completed the test, and is leaving the line.
- 4. Non-competing dogs are not allowed on the field trial grounds.
- 5. Please cooperate with those responsible for the proper conduct of this championship stake, especially with respect to the handling of traffic.
- 6. Please show your appreciation for the hospitality extended to us. Help keep the grounds clean Extinguish cigarettes and matches.

YOUR COOPERATION IS APPRECIATED

This is the Eighty-second Annual National Retriever Championship Trial. It is conducted by the National Retriever Club, Inc., under license from the American Kennel Club, Inc.

The retrievers competing in this trial have qualified in one or more of five ways and are limited to the following:

- 1. The winner of the 2022 National Championship Stake;
- 2. The winner of the 2023 National Amateur Championship Stake (must be handled by an Amateur in this Stake);
- 3. The winner of the 2023 Canadian National Championship Stake;
- 4. Winners of a first place, carrying five championship points, plus two additional championship points in Open, Limited, or Special All-Age Stakes in trials held within the year preceding the National Championship Stake, which are staged by members of the National Retriever Club, Inc., which are also members of, or Licensed by, the American Kennel Club.

National Championship Stakes must include at least ten tests or "series," equally divided between those on land and those on water.

At this trial, the judges will place only the winning dog, which is thereby entitled to the official designation,

"National Retriever Champion of 2023."

National Retriever Championship Rotation Procedure

The starting dog is drawn at the General Meeting the day previous to the beginning of the trial.

The rotation is determined by dividing the number of listed dogs in the catalog by a figure of four (4). These numbers are also announced during the General Meeting. Beginning with the starting dog, this division determines the dogs that start series one through four i.e. dog 35 starts an 80 dog trial. The division would be 35, 55, 75, 15. If any of these numbers are not listed in the callbacks the next higher number would start.

Following the fourth rotation, the rotation returns to the starting dog of the trial (35), excluding that dog and beginning with dog thirty-six (36), or the first working dog after dog thirty-six, five (5) working dogs (dogs listed on the callbacks) are counted and the sixth dog would start the fifth series.

Rotation for the remaining series of the trial would be, beginning with the dog that started the previous series and excluding that dog, counting five working dogs and the sixth dog would start.

No dog will start any series more than once. If the rotation landed on a dog that had previously started a series, that dog would be skipped unless all remaining dogs had already started a series, in which case the dog that was the first to start a series of the remaining dogs in the trial would be starting dog.

Prizes to the Winner only

- Standard AKC Rosette: National Retriever Field Champion of 2023
- Gold Club Pin National Retriever Club, Incorporated
- The Championship Trophy An Award of the National Retriever Club to the owner of the winner
- The Challenge Trophy An Award of the National Retriever Club, to remain in the possession of the owner of the winner until the running of the National Championship Stake the following year
- The Challenge Trophy An Award of the National Retriever Club to the handler of the winner, if a professional, to remain in the possession of the handler of the winner until the next winner of a National Championship Stake is handled by a professional. The handler also receives a replica of this trophy.



In 1991, the PRTA adopted the following set of ethical guidelines for training during the National Championship. Our members pledge to abide by them and we ask all contestants to voluntarily join us in this effort to promote good sportsmanship and fair competition.

Guidelines For Ethical Training at Nationals

The object of the National is to bring out the best performance.

TO FURTHER THIS END:

- As much training may be done each day as required BEFORE entering the trials grounds or AFTER running a test. NO TRAINING may be done after observing a test until after you have run.
- Train with as many people as required, excluding any person who has been to the trial and observed the test in progress.
- 3. Train on designated areas or ask permission on private property.
- 4. Keep corrections away from the public eye and ear.
- 5. Dispose of birds in a manner that will not affect public perception, or disrupt another training group.

It is our belief that once a test is viewed, any training which follows will be tainted and distorted by the viewing. Whether training alone or with a group, the viewing of the test will be reflected in what is done and how it is done. This influence is inevitable. Even if only the mannerisms of the handlers are influenced the test will be reflected. It will be reflected in the number of retrieves and whether the retrieves are short or long. It will be reflected in whether the retrieves are across the ditch, along the ditch, up the hill or down the hill, into the wind, crosswind, or downwind. Whether they be marks or blinds, whether "pattern work" sets up a mark or a blind, short or long, the test will be reflected. It may be reflected in so little as voice tone.

Any training done before actual viewing of the test is guesswork. Any training done after viewing is unfair advantage. This advantage is true even if the test is carried into the next day. When a test is carried to the next day the competitors have had the advantage of observing (or training prior to arriving at the trial) all the previous day's work. Often there is also the advantage of partial callbacks. Any "disadvantage" of running the following day is outweighed by the advantage of knowing what the other dogs have done. Training overnight is an unfair advantage to late competitors.

Rotation is the means of neutralizing the draw. By and large it does a good job. Dogs which run early in one test will run late in the next test. Sometimes running early is best, sometimes late is best. One thing for sure, once you've seen the test, any training done is not fair competition.

The future of our great sport depends upon the ethical guidelines which we place upon ourselves. In the final analysis we are only competing against ourselves. We're only winning or losing according to how we conduct ourselves.

When training at any time, caution should be taken to keep the image of field trials at a high level. Ask permission to train on private grounds. Keep corrections away from the public eye and ear and dispose of birds properly.

The object of the National is to bring out the best performance. The best performance involves every aspect of preparation and every part of ourselves. *The winner is within*.


